Jeremey Varley presented the two petitions before the group: Palmer amaranth and Myrtle spurge. He also reviewed considerations regarding the listing category of Turkish thistle, and language in the rule that was supposed to be added to legislation this year but was left off.

#### **PUBLIC COMMENT**

Roger Batt – Organization (IEOSA) opposed to Palmer listing

Patxi Larrocea Phillips – Organization opposed to Palmer listing. In favor of listing myrtle spurge. No stance yet on Turkish Thistle or editing the rule for EDRR language.

Mitch Whitmill – The Association of Noxious Weed Superintendents he represents has no position on myrtle spurge. They are in favor of reducing classification of Turkish Thistle. Jefferson County is opposed to listing myrtle spurge.

Bryce Fowler – Fremont County is opposed to listing myrtle spurge. They are also in favor of reducing the classification of Turkish Thistle.

Joe Slichter – In favor of reducing the classification of Turkish Thistle.

Bonnie Davis – Washington County is opposed to listing myrtle spurge.

Chase Youngdahl – In favor of listing myrtle spurge. In favor of reducing the classification of Turkish Thistle to the "Control" category.
