For control of downy brome (cheatgrass), mustards, and volunteer grain on land to be summer fallowed and planted to winter wheat, apply 0.44 lb/A of AAtrex Nine-O plus a registered, postemergence, chemical fallow herbicide to stubble following fall rains, after volunteer grain has begun growth (but not later than February 1). If weeds germinate in the spring, they should be controlled with stubble-mulch tillage.

DO NOT make a second application. **DO NOT** plant spring cereals; follow only with winter wheat.

Observe all directions, limitations, and precautions on the label of any product used in a tank mix combination with AAtrex Nine-O.

Precautions: 1) Use only on the Panhandle of Idaho, north of Grangeville. 2) Avoid overlapping. 3) Use only on silt loam or finer textured soils. 4) **DO NOT** graze treated areas within six months after application.

Chemigation: **DO NOT** apply this product through any type of irrigation system.
