On February 4, when advocates from the Idaho Agricultural Aviation Association testified in the House Committee on Agricultural Affairs, they explained they wanted to strike the first line of IDAPA 02.03.03.550.03 which creates setbacks from hazard areas for mean sustained wind velocity from 0-3

MPH. However, due to the nature of the legislative review process, the committee was required to strike the entire subsection IDAPA 02.03.03.550.03. The Association stated openly on the record they did not want to eliminate the second, third, and fourth lines in that section. What is the Department's reasoning for striking that entire section?

the National Coalition on Drift Minimization, which include representatives from federal (including EPA and the U. S. Department of Agriculture) and state agencies and tribes, pesticide and equipment manufacturers, university scientists, and others, who have focused their attention on enhancing pesticide applicator education, application research, and regulatory initiatives to foster reductions in spray drift definition as: Pesticide drift is the movement of pesticide dust or droplets through the air at the time of application or soon after, to any site other than the area intended.
