<b>PEPPERS, BELL/CHILE (30)</b>	1/2 - 1	Apply uniformly with ground equipment in a minimum of 20 gal of water per acre. <b>Direct-seeded:</b> <ul style="list-style-type: none"> <li>• <b>Postemergence</b> - Apply SANDEA as a directed spray 28 days after planting or when the plants have reached a minimum of six inches in height, but prior to flowering. Use lower rates on lighter textured soils with low organic matter.</li> </ul> <b>Transplanted:</b> <ul style="list-style-type: none"> <li>• <b>Post-transplant</b> - Apply SANDEA as a directed spray 21 days after transplanting or when the plants have reached a minimum of six inches in height, but prior to flowering.</li> </ul>
