## Swine

#### All swine require:

- CVI with complete physical destination address.
- Individual, official identification listed on the CVI.
- The following statements:
  - ⇒ "These swine have not been fed raw garbage."
  - ⇒ "These swine have not received any pseudorabies vaccine."
  - ⇒ "To the best of my knowledge, these swine have not within the last 30 days originated from a premises known to be affected by PEDv and have not been exposed to PEDv."
- All breeding swine not originating from a brucellosis-free herd/state must have a negative brucellosis test within 30 days before movement into Idaho.

Please call our office if swine originate from an area which is not stage IV or V for pseudorabies.

### Birds

#### All birds require:

 CVI with complete physical destination address.

# Poultry, game birds, ratites, wildfowl & waterfowl also require:

- VS 9-3 if from a certified NPIP flock, or
- Negative *Salmonella pullorum*-typhoid test within 30 days before entry.

#### All wild birds also require:

- Entry Permit.
- Idaho Fish and Game may have further requirements.



#### **Division of Animal Industries**

This brochure provides the basic requirements for animals entering Idaho. Always remember that you are responsible for being in compliance with Idaho import requirements.

### Cattle

# Cattle that require identification listed on the CVI\*:



- All dairy cattle of any age\*β
- All sexually intact beef cattle (male and female) 18 months of age or older
- All cattle moving interstate for shows or rodeos

#### All cattle require:

- CVI with complete physical destination address.
- If being used for rodeo, all cattle ≥6 months require a negative TB within 12 months before entering Idaho.

#### Female cattle also require:

- Vaccination for brucellosis with legible tattoo recorded on CVI (<4 months and approved feedlots are exempt).
- All dairy breeds and unvaccinated females require an entry permit.
- All dairy breed females ≥ 6 months require a negative Tuberculosis test within 60 days prior to entering Idaho (approved feedlots are exempt).

#### Intact male cattle also require:

- All bulls require an entry permit.
- "Virgin Bull" statement if virgin and <18
  months, or negative Trich test within 60
  days if ≥18 months (approved feedlots
  are exempt).</li>
- All dairy breed males ≥6 months require a negative TB within 60 days before entering Idaho (approved feedlots are exempt).
  - \*β- Dairy steers require identification; however, it does not need to be listed.

# Cattle Identification

#### **Accepted forms of ID:**

 Official ear tags (Orange or Silver USDA tags, 840-RFIDs).

#### Non-Accepted forms of ID:

- Registration tattoos or other breed association identification
- Trich tags
- Farm/Ranch tags
- Brands from state other than Montana, Nevada, Oregon, Utah, or Wyoming
  - If using brands, official ID is still required, and the CVI must have the common brand and statement that all animals have individual official ID.

## **Other Species**

# Fur species (skunk, raccoon, fox, and \*mink) require:

- CVI with complete physical destination address.
- An entry permit.
- \*Mink require a negative Counterelectrophoresis (CEP) test within 30 days before importation.

#### All camelids require:

 CVI with complete physical destination address.

#### All fish and fish eggs require:

- CVI or current AFS Health Inspection with full physical destination address.
- An entry permit.
- Invoice or Bill of Lading.


## Equines

#### All equines require:

- CVI with complete physical destination address. GlobalVetLink EECVIs are the only extended certificates currently approved in Idaho.
- Negative EIA test within 12 months before entering Idaho.
  - Pending tests are not acceptable.
  - Untested horses may only be destined to an equine slaughter facility and require an entry permit.

### Cervidae

#### **All Cervidae require:**



- CVI with complete physical destination address.
  - 2 listed forms of official identification
- Entry Permit (+unique permit number).
- Origination from herd actively participating in CWD Herd Certification Program and have certified CWD free status.
- Completed Tuberculosis testing and *P. Tenius* requirements.

## **Sheep & Goats**

#### All sheep and goats require:

- Entry Permit
- Official & Flock IDs listed on CVI with complete physical destination address.

# Intact dairy goats and intact male sheep ≥ 6 months also require:

 Negative brucellosis test within 30 days before entry (*B. ovis* for sheep and *B. melitensis* for goats).
