## **APPLICATION FOR IDAHO APPROVED FEEDLOT, BUYING STATION, or LIVESTOCK TRADER LOT**

### **APPROVED FEEDLOTS**

The Idaho Approved Feedlot shall be approved on a yearly basis; however, on written request and after emptying the feedlot of restricted animals, the Approved Feedlot status may be dissolved by request of either party, as provided by IDAPA 02.04.20. Approved feedlot status shall expire on September 1 of each year. It shall be the responsibility of feedlot management to apply each year for renewal of approved status.

The premises for which an application is submitted shall be such that all animals can and will be secured within the feedlot. Pasturing or grazing restricted animals is not allowed. The feedlot must meet all requirements of IDAPA 02.04.20, specifically, Subsections 200 through 256.

*Approved feedlot status shall remain in effect until September 1 unless revoked by the Administrator or there is a change in ownership or operator.*

### **BUYING STATION**

The Idaho Buying Station shall be approved by the ISDA administrator. *Approved buying stations shall remain in effect unless the status is revoked by the Administrator or there is a change in ownership or operator.* It is the responsibility of the new buying station owner or operator to apply for reinstatement of approved status.

The premises for which an application is submitted shall be such that all animals can and will be secured within the buying station. Pasturing or grazing animals is not allowed. The buying station must meet all requirements of IDAPA 02.04.26 Subchapter A, specifically, Subsections 300 through 370.

### **LIVESTOCK TRADER LOT**

The Idaho Livestock Trader Lot shall be approved by the ISDA administrator. *Approved livestock trader lots shall remain in effect unless the status is revoked by the Administrator or there is a material change in operation of the lot.* It is the responsibility of the livestock trader lot owner or operator to apply for reinstatement of approved status upon a material change in operation.

The premises for which an application is submitted shall be such that all animals can and will be secured within the livestock trader lot. Pasturing or grazing animals is not allowed. The livestock trader lot must meet all requirements of IDAPA 02.04.26, Subchapter A, specifically, Subsections 500 through 570.
