The meeting was called to order by Lloyd Knight at 1:30 p.m. MT.

**INTRODUCTIONS**

Lloyd introduced members of the ISDA team to assist with rulemaking and reviewed the process and what to expect. He stated that this meeting was to finalize the rule and it will be in the October bulletin. He also commented that proposed language was received from the Idaho Dairyman’s Association.

**PROPOSED CHANGES**

Dr. Leibsle reviewed the proposed changes suggested in the previous meeting.

It was discussed that Malignant Catarrhal Fever be moved from the Reportable Disease List to the Notifiable List.

Avian Influenza was moved to the ‘multiple species’ section under “Reportable” diseases.

Section 360 – Exemption from public disclosure Confidentiality. The following is the change recommended by the Idaho Dairyman’s Association:

**360. EXEMPTION FROM PUBLIC DISCLOSURE; CONFIDENTIALITY .**

All data and information collected or generated under these rules or Chapter 2, Title 25, Idaho Code, including but not limited to animal health records, communications, inspection findings, interviews, reports, statements, studies, and test results, is confidential to the persons and places involved and shall be exempt from public disclosure. The foregoing shall not prohibit public disclosure of data and information in an aggregated, blinded form that does not compromise the foregoing.

Bob Nearabout explained the new language that was submitted by the Idaho Dairyman's Association to be included in Section 360 of the rule. He stated the language is more specific than statute. The name is protected from being released.

David Claiborne stated that the language closely follows what the statute states but has clarification.

#### Subchapter B

Most is clarification of language and redaction of redundancy.

During the proposed changes section of the meeting, there were additional questions and statements from the public that were addressed at that time. There were no additional public comments during the Public Comment period.
