**Use Restrictions:** Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. Keep all other persons out of the treated area during this application.

### ALFALFA

**USE RESTRICTIONS:** For control of Wyoming ground squirrels (*Urocyonellus elegans*) in alfalfa. All applications must occur shortly after a cutting of the hay, and/or prior to the next growth's attaining a length of 2 inches. Alfalfa forage from treated areas must not be harvested until it reaches maturity.

**PREBAITING (Mandatory):** Pre-bait with a 50/50 mixture of ground corn and wheat to enhance bait acceptance by Wyoming ground squirrels. Apply the pre-bait mixture at 6 lbs. per acre 2-3 days prior to using ZP Rodent Bait AG.

**BROADCAST BAITING:** This product may be broadcast by air or ground-driven dispensing devices. Apply at a rate up to 6 lbs. (0.12 lbs. active ingredient) per acre. Make only one application per year.

### BARLEY

**USE RESTRICTIONS:** For control of Wyoming ground squirrels (*Urocyonellus elegans*) in growing-season and preplant applications in barley. Do not apply this product to barley within 50 days of harvest. Do not graze animals in treated areas.

**PREBAITING (Mandatory):** Pre-bait with a 50/50 mixture of ground corn and wheat to enhance bait acceptance by Wyoming ground squirrels. Apply the pre-bait mixture at 6 lbs. per acre 2-3 days prior to using ZP Rodent Bait AG.

**BROADCAST BAITING:** This product may be broadcast by air or ground-driven dispensing devices. Apply at a rate up to 6 lbs. (0.12 lbs. active ingredient) per acre. Make only one application per year. All applications must be made prior to boot stage.
