

## Sheep & Goats

### All sheep and goats require:

- Entry Permit from the Sheep and Goat Health Board (208-803-5084).
- Official ID and Flock ID listed on CVI with complete physical destination address.

### Intact dairy goats and intact male sheep $\geq$ 6 months also require:

- Negative brucellosis test within 30 days before entry (*B. ovis* for sheep and *B. melitensis* for goats).

## Pigs

Refer to "Swine" in the Livestock Brochure.

## Equines

### All equines require:

- CVI with complete physical destination address. GlobalVetLink EECVIs are the only extended certificates currently approved in Idaho.
- Negative EIA test within 12 months before entering Idaho. Pending tests are not acceptable.
- \* The only exemption is foals less than 6 months old with their EIA negative dam. Other Non-EIA tested horses may only be destined to an equine slaughter facility and require an entry permit.



### Division of Animal Industries

This brochure provides the basic requirements for animals entering Idaho. Always remember that **you are responsible for being in compliance with Idaho import requirements.**

## Import and Export Requirements



## Dogs & Cats

### All dogs and cats require:



- CVI with complete physical destination address.
- All dogs and cats 12 weeks of age and older require current rabies vaccination.

## Exotic Small Animals

### Exotic small animals include:

- Reptiles
- Amphibians
- Birds
- Fish
- Rodents
- Rabbits



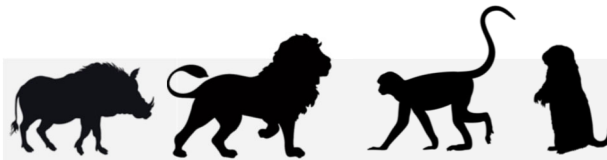
### All small animals require:

- CVI with complete physical destination address.
- More requirements to be fulfilled for small **Deleterious Exotic (DE)** and **Invasive Species**.
- Wildlife may require additional permits from the Idaho State Department of Fish and Game.

## Reptile and Amphibians

### All reptiles & amphibians require:

- CVI with complete physical destination address.
- More requirements if listed as an **Invasive Species**.



## Deleterious Exotic (DE) Animals

**"Animals which have been determined... to be dangerous to the environment, livestock, agriculture, or wildlife of the state".**  
**Some DEs are only allowed to be possessed by AZA facilities.**

*Small DE animals include (full list on website):*

- European Hedgehogs
- Prairie Dogs
- \* South American rodents except guinea pigs and chinchillas
- Non-native *canidae* and *Felidae*

### All DE animals require:

- CVI with complete physical destination address.
- Possession permit.
  - ◊ Prior to purchasing, importing, breeding, or in any other way possessing
- An entry permit or approved eCVI.

## Invasive Species

**Animals "capable of causing economic or environmental harm and has the ability to spread..." and highly competitive against native species.**

*Small Invasive Species include (but not limited to):*

- Red-eared sliders
- Bullfrogs
- Snapping Turtles
- \* Monk Parakeets (Quaker Parrots)



**Qualified educational institutions may contact ISDA at (208) 332-8686 for permit information to transport and possess Invasive Species.**

## Birds



### All birds require:

- CVI with complete physical destination address.

### Poultry, ratites, wildfowl & waterfowl also require:

- VS 9-3 if from a certified NPIP flock, or
- Negative *Salmonella pullorum-typhoid* test within 30 days before entry.

### All wild birds also require:

- An entry permit.

### Monk Parakeets (Quaker Parrots) (*an Invasive Species*) also require:

- Invasive Species Permit Application.
- An entry permit.



## Fish

### All fish and fish eggs require:

- CVI or current AFS Health Inspection with full physical destination address.
- An entry permit.
- Invoice or Bill of Lading.

## Exotic Large Animals

### All elephants require:

- CVI with complete physical destination address.
- An entry permit or approved eCVI.
- Negative TB trunk wash within past 12 months.
