COMPLIANCE NOTICE FOR SMALL FARMS

As of January 26, 2024 small and large farms must comply with harvest and postharvest agricultural water requirements in the <u>Produce Safety Rule</u>. Very small farms must comply in January 26, 2025.

After this date, all covered farms with agricultural water in harvest or postharvest activities must comply with the following summarized rules of Subpart E:

Annual water system inspection by farm	Record of annual water system inspection by farm
Records of treated surface microbial water quality profile: 20 tests over 2-4 years	Records of treated surface water tests: 5 annually following established profile

Records of ground microbial water quality profile: 4 tests in 1 year	Records of ground water tests: Once annually following established profile
Records for municipal water: Public Water System test that demonstrates 0 detectable generic E. Coli	Records for municipal water: Public Water System certificate of compliance that demonstrates 0 detectable generic E. Coli
