BACKGROUND

The Idaho State Department of Agriculture (ISDA), in cooperation with the Nursery Advisory Committee (NAC), annually award financial grants to support research that would benefit the Idaho nursery industry. These grants are funded primarily through the Nursery Research Fee, paid to the ISDA through Idaho Nursery/Florist license fees. In 2024, 3 projects were supported with a total allocation of approximately \$42,000.

EVALUATION

Submissions are reviewed and prioritized by the Idaho Nursery Advisory Committee. A submitter may be asked to modify & re-submit a proposal if the committee decides it warrants further review. The committee makes the final selection of awardees. Grant awards are administered and issued by the ISDA. For questions about the funding process, please contact the ISDA. 2025 OBJECTIVES

Grants are awarded to projects which focus on five main categories that result in:

Prevention and elimination of plant diseases and insect pests, both common and emergent.

Development and improvement of cultural methods, technologies, or cultivars that are beneficial to the nursery industry.

DELIVERABLES

A brief written mid-year progress report and a final report, detailing the research results are required as part of the grant process. Reports must be submitted to the ISDA for invoices/awards to be approved. Interim (Mid-term) Progress reports are due August 31. Final reports are due December 31st.

AWARDS

Final award letters will be delivered via postal mail and/or email. Funding for all approved projects is provided in the following allotments:

- 50% paid upon project approval and full execution of the award agreement with the ISDA.
- 50% payment paid upon receipt and approval of a final report

For approved projects totaling less than \$5,000, funding will be paid upon project approval.
